## CHANGES TO REG CC.

Regulation CC, which implements the Funds Availability Act, is increasing daily limits the Credit Union is required to make available "next day" on check deposits. Next day availability is currently \$200, and will increase to \$225. Additionally, large deposits are currently defined as aggregate amounts over \$5,000. After July 1, 2020, large deposits will be defined as aggregate amounts over \$5,525. The rules of placing a hold on check deposits will remain the same, however the amounts made available "next day" will increase.
